AN ORDINANCE  
LEVYING TAXES FOR THE FISCAL YEAR BEGINNING  
MAY 1, 2016 AND ENDING APRIL 30, 2017 IN THE  
VILLAGE OF MONEE, WILL COUNTY, ILLINOIS

WHEREAS, the Mayor and Board of Trustees of the Village of Monee, County of Will, State of Illinois, on the 22nd day of June, 2016, passed the annual Appropriation Ordinance for the said Village of Monee, for the fiscal year beginning May 1, 2016 and ending April 30, 2017, the amount appropriated being the sum of Sixteen Million Three Hundred Sixty Nine Thousand One Hundred Fifty-Nine and 00/100 (\$16,369,159) Dollars and;

WHEREAS, said Appropriation Ordinance was published by the Village of Monee, Will County, Illinois in pamphlet form on the 22nd day of June, 2016;

NOW THEREFORE BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Monee, Will County, Illinois.

Section 1. That of the amount heretofore lawfully appropriated for said fiscal year, is hereby levied and assessed for the fiscal year of the Village of Monee beginning May 1, 2016 and ending April 30, 2017 on all real estate within the said property as the same is the sum of one million four hundred ninety two thousand three hundred and no 100 (\$1,492,300) dollars for the following objects and purposes and in the following amounts as indicated in the center column designated "To Be Paid From Tax Levy".




